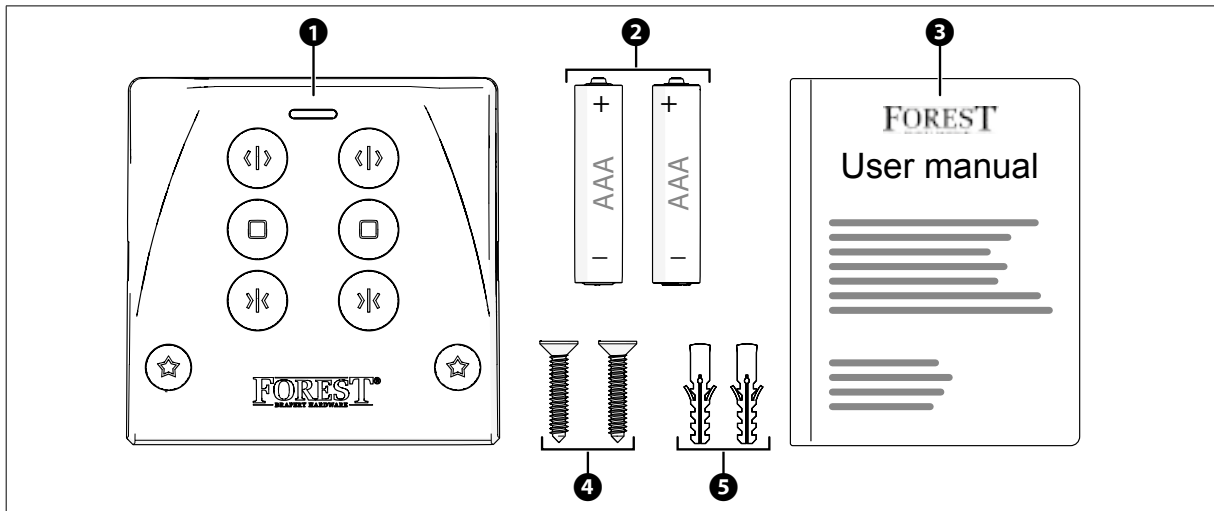

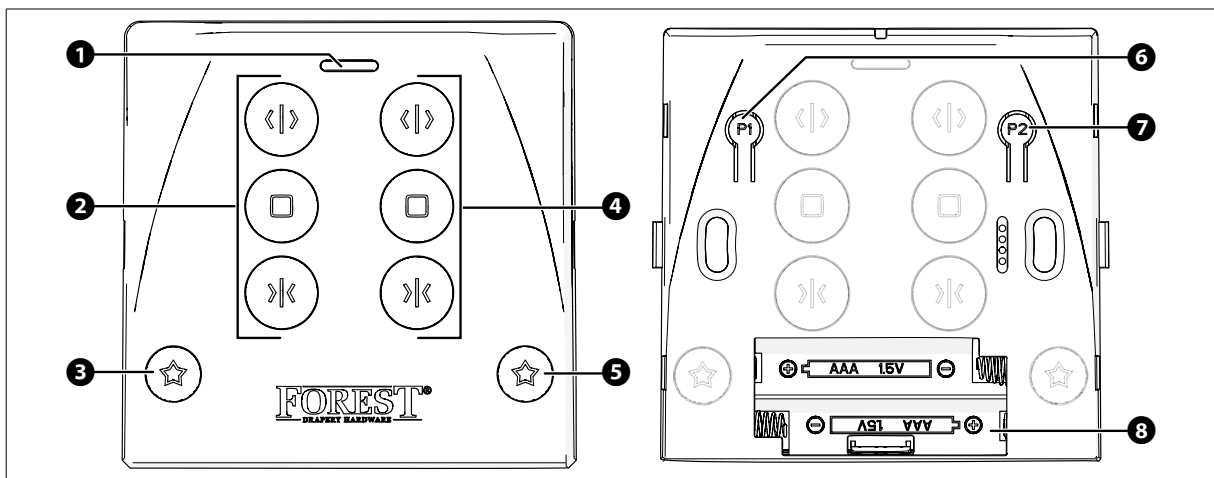



## 3. Safety

### 3.1. INTENDED USE

- This product is intended as a wall mounted wireless remote control for use with motorised Forest systems.
- This appliance is not intended for use by persons (including children) with reduced physical, sensory or mental capabilities, or lack of experience and knowledge, unless they have been given supervision or instruction concerning use of the appliance by a person responsible for their safety.
- This product is only intended for indoor use.

### 3.2. SAFETY INSTRUCTIONS

#### ⚠ WARNING

- Always read and understand this manual and keep this document close to the product at all times. Go to [www.forestgroup.com](http://www.forestgroup.com) for the online version of the user manual.
- Children should not be near the installation of the wall switch on the installation location.
- Children should be supervised to ensure that they do not play with the appliance.
- Do not dismantle, open, or shred batteries. Chemicals inside the batteries can combust upon contact with ambient air.
- Seek medical advice immediately if battery has been swallowed.

#### ⚠ CAUTION

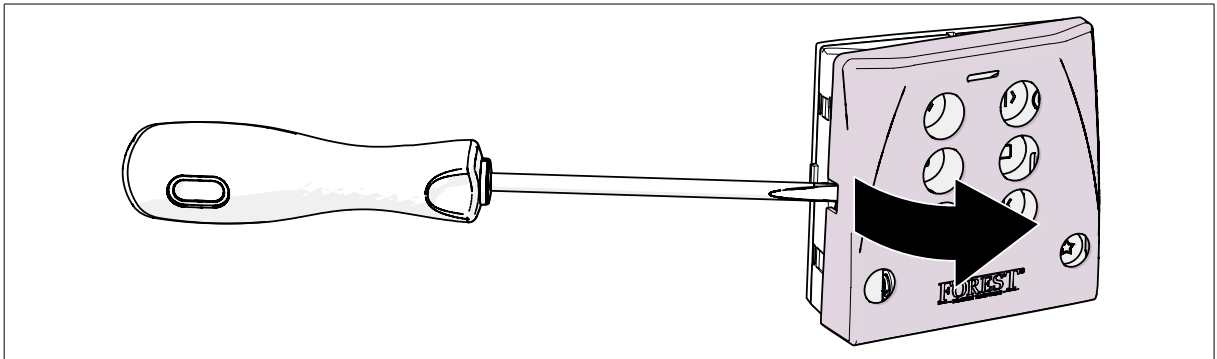
- Do not expose the device to high temperatures or place it in direct sunlight.
- This product is for indoor use only, do not use in outdoor or in humid environments, such as bathrooms or swimming pools.
- Do not subject batteries to mechanical shock.

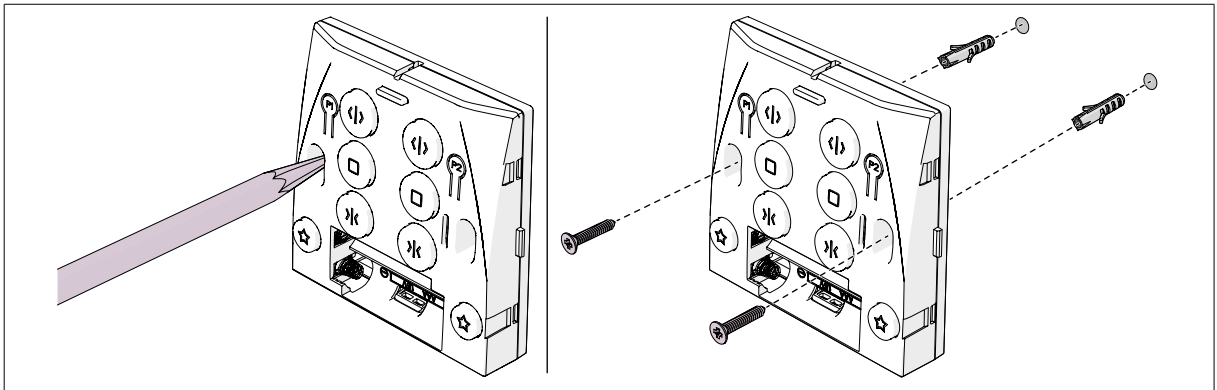
## 4. Installation

1. Use a flathead screwdriver to carefully remove the **front cover** from the product.

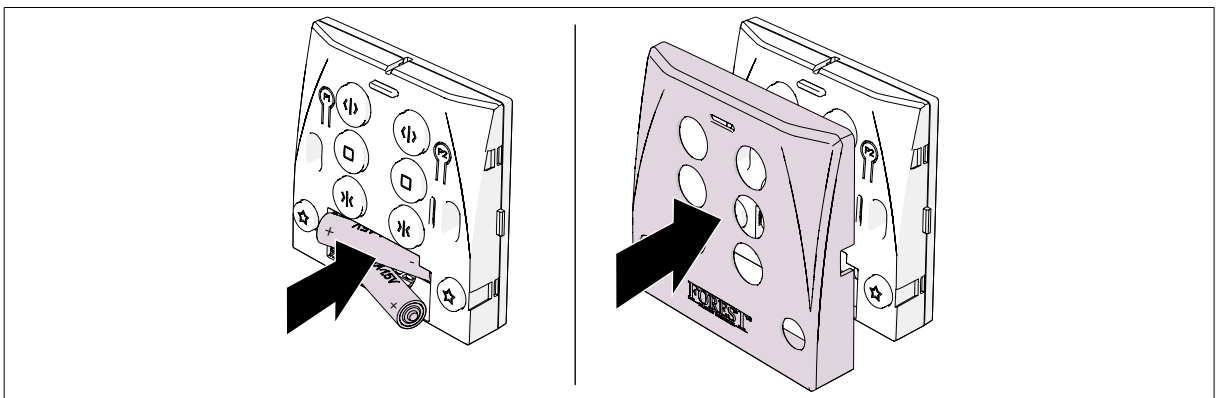

2. Use the screw holes as a template to **mark** your drilling location.
3. Use an electric drill and 4 mm masonry drill bit to **drill** the two mounting holes.
4. Insert the included **plastic plugs** in the two holes.
5. Use a cross-head screwdriver and the two included screws to **mount** the product to the wall.



6. Insert the **2× AAA batteries** into the battery compartment.  
**i** Ensure that the plus (+) and minus (-) poles are inserted correctly to avoid a short circuit.
7. Click the **front cover** back on the product.



## 5. Pairing

The remote control needs to be paired with the Forest Shuttle before it can be operated.

- ❗ Pairing cannot be done under group channel or 0 (all) channel.

### 5.1. PAIRING THE SHUTTLE S/M/L OR SHUTTLE ION

1. Use a pen to press the **P button** on the Shuttle 3 times.

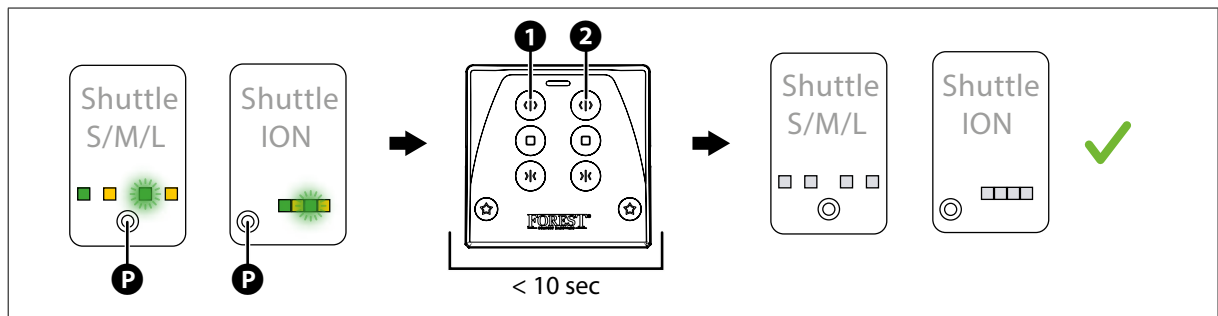
The LED indicator scrolls from the first, to the second, and finally the third LED.

2. Press and hold the **P button** a 4th time, for 5 seconds.

The LED indicator on the motor flashes green.

3. Within 10 seconds, press the **Open channel 1** or **Open channel 2** button to pair the Shuttle to the remote.

The green LED indicator on the motor switches off, indicating the remote is paired to the Shuttle.



### 5.2. PAIRING THE SHUTTLE GO

1. Press the **P button** on the Shuttle 3 times.

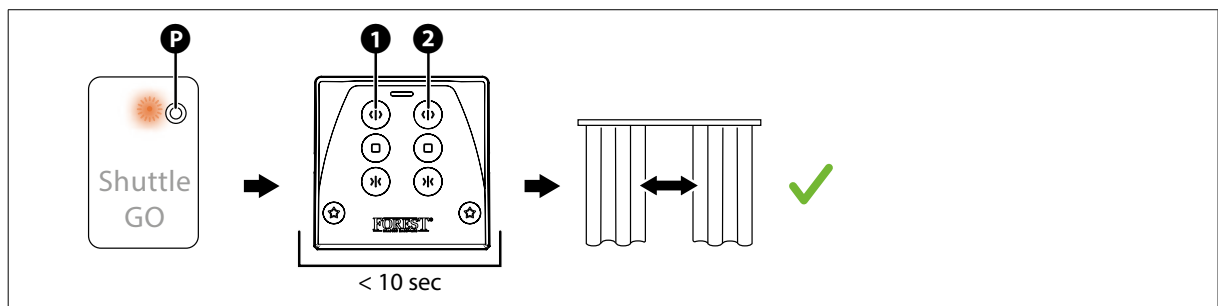
The LED indicator on the motor is orange.

2. Press and hold the **P button** a 4th time, for 5 seconds.

The LED indicator on the motor flashes orange.

3. Within 10 seconds, press the **Open channel 1** or **Open channel 2** button to pair the Shuttle to the remote.

The curtains move, indicating the remote is paired to the Shuttle.



### 5.3. PAIRING TO A TUBULAR MOTOR

To pair the product to a Forest tubular motor, see the user manual of the respective tubular motor for more information.

## 6. Use

### 6.1. NORMAL OPERATION

1. Press the **Open button** to open the curtains.
2. Press the **Stop button** to stop the curtains at any desired location.
3. Press the **Close button** to close the curtains.

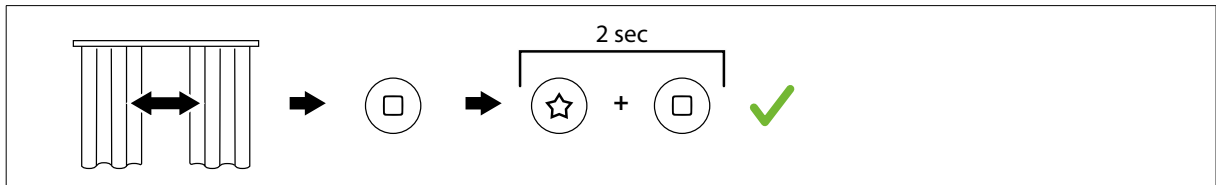
### 6.2. SETTING UP THE FAVOURITE POSITION

The favourites buttons allow you to set a custom curtain position for each motor. Pressing the button(s) moves the curtain automatically to the specified position.

**i** The favourite position can only be set up if the end positions of the motors are configured. This only works for motors with Forest Link protocol.

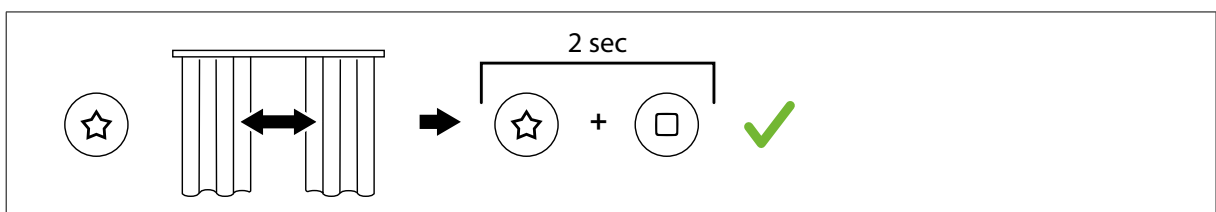
1. Use the **Open**, **Close**, and/or **Stop buttons** to move the curtains to the desired favourite position.
  2. Press and hold the **Favourites** and **Stop button** for 2 seconds to set up the current position as the favourite.
  3. Press the **Favourite button** from any position to move the curtains to the favourite location.
- i** Only one favourite location can be saved per motor.



To remove the favourite position:

1. Press the **Favourite button** from any location to move the curtains to the favourite location.
2. Press and hold the **Favourite** and **Stop button** for 2 seconds to remove the current position as the favourite.

The favourite location is now removed.



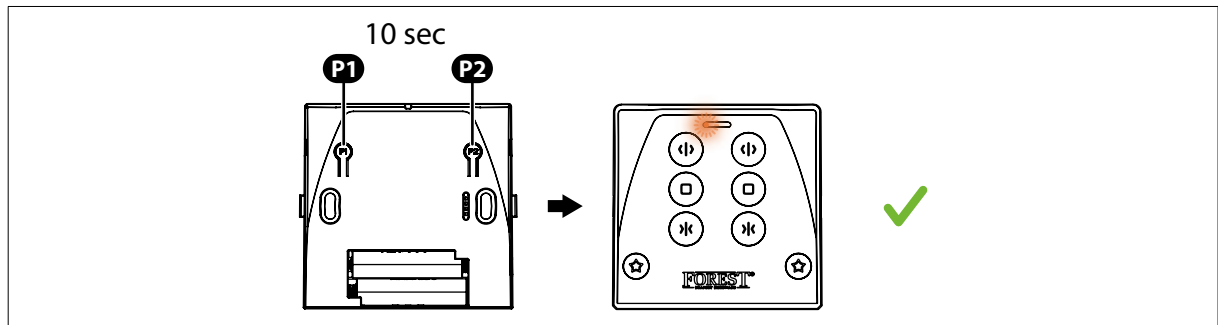
### 6.3. ACTIVATING CHILD LOCK / HOTEL LOCK

With child lock / hotel lock activated, the dual button functions (such as setting up Favourites) are disabled.

1. Use a flathead screwdriver to carefully remove the **front cover** from the product.
2. Press and hold the **Program button channel 1** or **Program button channel 2 buttons** for 10 seconds.

The child lock / hotel lock is now activated.

- ⓘ Wait at least 30 seconds before sending other commands.



Repeat the steps of activating the child lock / hotel lock to deactivate the child lock / hotel lock.

## 7. Troubleshooting

Problem	Possible cause	Possible solution
The LED indicator flashes orange when a button is pressed.	The batteries are almost empty.	Replace the batteries.
The product does not work.	The product is not paired correctly.	Follow the instructions in chapter Pairing to pair the product to the curtain motors.
	Make sure the batteries are inserted correctly and are not empty.	Replace the batteries.
	The product does not work with your curtain motor.	The product only works with Forest Shuttle motors, Forest tubular motos with internal receiver, and Forest LED systems with RF receiver. Make sure your curtain motor is compatible with the product.
My curtain or tubular motor does not have Forest Link Protocol, and the response is very slow.	The product needs to be set to the original RF protocol.	Remove the batteries. Press and hold the Stop button and reinstall the batteries. The LED indicator flashes once. Follow the instructions in chapter Pairing to pair the product to the curtain motors. The motors always require re-pairing to the remote.
